RE: Anthem expands specialty pharmacy pre-certification list

Dear Provider:

Anthem Blue Cross and Blue Shield and our subsidiary company, HMO Colorado (collectively Anthem) will be expanding the Specialty Pharmacy pre-certification list.

Effective for dates of service on and after November 1, 2018, the following specialty pharmacy codes from new or current medical policies or clinical guidelines will be included in our pre-certification clinical review process.

Anthem’s pre-certification clinical review of these specialty pharmacy drugs will be managed by AIM Specialty Health® (AIM), a separate company.

The following clinical guidelines or medical policies will be effective November 1, 2018:


