RE: Anthem expands specialty pharmacy level of care (clinical site of care) drug list

Dear Provider:

Effective for dates of service on and after January 1, 2019, the following specialty pharmacy codes from new or current medical policies or clinical UM guidelines will be included in our existing specialty pharmacy level of care review process.

Anthem's level of care pre-certification clinical review of these specialty pharmacy drugs will be managed by AIM Specialty Health® (AIM), a separate company.
